I UNDERSTAND THAT ENTERING THIS SCREENPLAY MAY RESULT IN THE PRODUCTION OF THE SCREENPLAY TO VIDEO OR FILM FORMAT BY VOLUNTEER PERSONS WHO MAY OR MAY NOT HAVE THE SKILLS NEEDED TO COMPLETE THE PROJECT.

I UNDERSTAND THE PURPOSE OF THIS EXERCISE IS TO WORK WITH OTHER INTERESTED PRODUCERS, DIRECTORS, ACTORS, AND CRAFTSPEOPLE TO CREATE POTENTIAL VIDEO OR FILM MAKING TEAMS FOR USE IN FUTURE PROJECTS.

I ACKNOWLEDGE THAT THE IDEAS I SUBMIT FOR THIS SCREENPLAY ARE NOW EFFECTIVELY SUBMITTED TO PUBLIC DOMAIN AND ROCHESTER MOVIE MAKERS ASSUMES NO LIABILITIES FOR PROTECTING THE IDEAS OR CONTENT EXPRESSED IN THE SCREENPLAY FROM ANY OTHER WRITER OR PRODUCER.

I HOLD ROCHESTER MOVIE MAKERS HARMLESS FROM ANY ACTIONS THAT MAY RESULT FROM DISPUTES WITH MEMBERS OF THE VOLUTEER VIDEO/FILM MAKING TEAM THAT MAY BE ASSIGNED TO PRODUCING MY SCREENPLAY.

I represent to the best of my knowledge that the consent of no other persons, firm corporation or labor organization is required to enable Producers to use Screenplay and that such use will not violate the rights of any third parties.

I acknowledge that nothing herein requires Rochester Movie Makers, its board of directors, or any members of Rochester Movie Makers to be indebted to writer or any producers or workers involved with the production of screenplay.

I understand any revenues or liabilities that may result from my submission of the screenplay to the Rochester Movie Makers Summer Shorts Exercise are exclusively made by myself and the producers/actors/workers on the project and Rochester Movie Makers is not liable for any agreements or disagreements that may arise from costs or revenues generated by project.

This agreement contains the full and complete understanding between RMM and Screenwriter and supersedes all prior agreements and understandings pertaining hereto and cannot be modified except by writing signed by each party.
